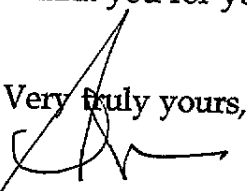

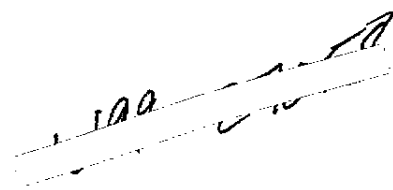

ARTICLE. 1 NAME

The name of this limited Liability Company is VFD ACQUISITIONS, L.C.

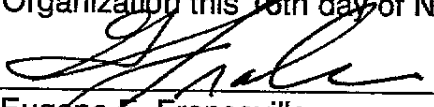

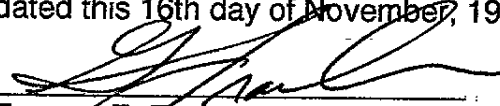
