**AMENDED ARTICLES TO THE ARTICLES OF ORGANIZATION OF
JAICE, L.C.**

The following is an amendment to the articles of organization of JAICE, L.C. a Florida limited liability company incorporated on December 13, 1999 and bearing filing number L99000008883.

The articles of organization of JAICE, L.C. shall now read as follows.

ARTICLE I. NAME

The name of the limited liability company is: **JAICE, L.C.**

L99-8883

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The street address of the limited liability company's initial principal office is One South Ocean Blvd., City of Boca Raton, State of Florida, 33432. However that limited liability company shall have the power and authority to establish branch offices at any other place or places as the members may designate. The mailing address of the corporation is One South Ocean Blvd., City of Boca Raton, State of Florida, 33432.

ARTICLE III. EXERCISE OF POWERS

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed by a manager under the direction of the members of this limited liability company. This Article may be amended from time to time in the regulations of the limited liability company by a unanimous vote of the members of the limited liability company.

ARTICLE IV. MANAGEMENT

Management of this limited liability company shall no longer be reserved to its members. This limited liability company shall now be managed by one (1) manager who will be elected by the majority vote of the members of this limited liability company. The name and address of the person who shall serve until a successor is appointed shall be: Saintomer F. Horn, 9039 S.W. 1st Street, Boca Raton, Florida 33128. All prior managers shall no longer serve as managers of the limited liability company.

ARTICLE V. MEMBERSHIP RESTRICTIONS

Members shall have the right to admit new members by unanimous consent. Contributions required of the new members shall be determined as of the time of admission to the limited liability company.

A member's interest in the limited liability company may not be sold or otherwise transferred except with unanimous written consent of all members.

On death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business on unanimous consent of the remaining members.

ARTICLE VI. DURATION

The limited liability company shall exist until December 31st, 2050, or until dissolved in a manner provided by law, or as provided in the regulations adopted by the members.

ARTICLE VII. REGISTERED OFFICE AND AGENT

The street address of the registered office of the limited liability company shall be One South Ocean Blvd., City of Boca Raton, State of Florida, 33432, and the name of its registered agent at such address shall be Jean-Pierre Cohen-Salomon.

I further agree to comply with the provisions of all statutes relative to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 608, F.S. Or, if this document is being filed to merely reflect a change in the registered office address, I hereby confirm that the limited liability company has been notified in writing of this change.

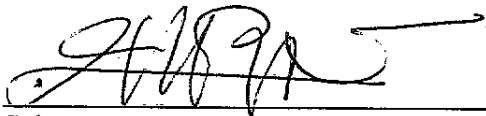
