ARTICLES OF ORGANIZATION

The undersigned, being a duly authorized representative f a member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act (the "Act"), Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:
