The name of this limited liability company shall be CREWS, L.L.C. (the "Company").

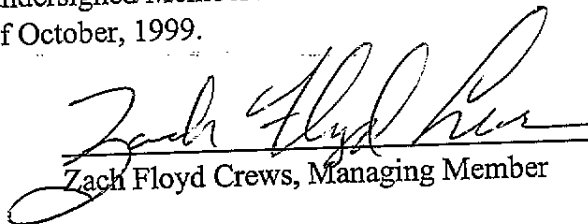
**ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS**
