### ARTICLES OF ORGANIZATION FOR COMPUTER GRAPHIC RESOURCES, L.L.C.

### A FLORIDA LIMITED LIABILITY COMPANY

The undersigned acting as the organizer and the Member of COMPUTER GRAPHIC RESOURCES, L.L.C., under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

### ARTICLE I NAME
