ARTICLES OF ORGANIZATION OF SEMINOLE RC, L.L.C.

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act") , for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

1. NAME.


