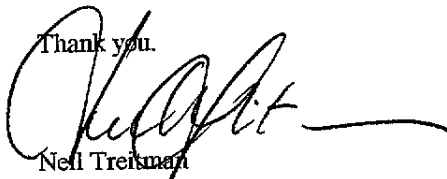

ARTICLES OF ORGANIZATION

OF

CHARTER DEVELOPMENT SERVICES INTERNATIONAL, L.L.C.

THESE ARTICLES OF ORGANIZATION are entered into this 14 day of December 1999, and are effective as of the date of execution of these Articles of Organization.

1. The name of the limited liability company shall be CHARTER DEVELOPMENT SERVICES INTERNATIONAL, L.L.C. (the "Company").

1. The term of existence of the Company shall commence with the filing of these Articles of Incorporation with the Secretary of State of the State of Florida, and shall continue until December 31, 2023, unless sooner dissolved pursuant to the Regulations, the Articles, or by operation of law.
