ARTICLE III - DURATION

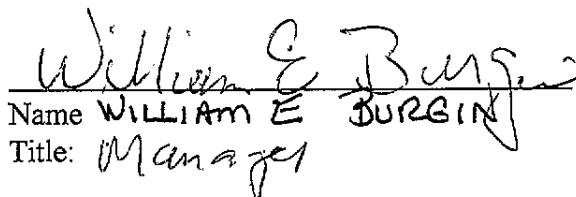
