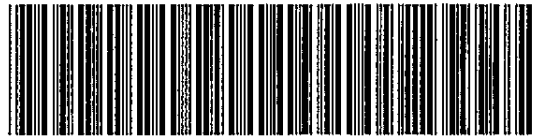

The name of the Limited Liability Company shall be CHANGED to "Trinity Advisors, L.L.C."


