1. **NAME.** The name of this limited liability company (the "Company") is **Stockingbrook Properties, LLC.**
 2. **DURATION.** The period of duration of the Company shall be perpetual.
 3. **PURPOSE.** The purpose and business of the Company shall be to engage in any lawful act or activity which may be carried on by a limited liability company under the Act.
 4. **MAILING ADDRESS AND STREET ADDRESS OF PRINCIPAL OFFICE AND REGISTERED OFFICE.** The mailing address and street address of the principal office and registered office of the Company is: 1640 Lis court Drive, Venice, Florida 34292.
