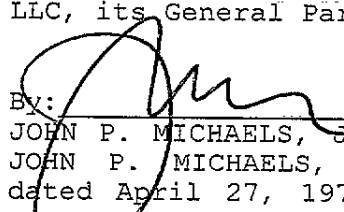
1. The name of the limited liability company is UMagic Investors, LLC (the "Company").
