1. **NAME OF LIMITED LIABILITY COMPANY.** The name of this limited liability company is **Pineapple Land Holdings, LLC** (the "Company"). The Articles of Organization were filed on December 23, 1999 and assigned document number L99000009176.

2. **EFFECTIVE DATE OF DISSOLUTION.** The effective date of the dissolution of the Company is November 10, 2008.

3. **OCCURRENCE THAT RESULTED IN DISSOLUTION.** The dissolution of the Company was authorized by the Unanimous Written Consent of the voting members of the Company under F.S. 608.441 on November 10, 2008.

4. **DEBTS, OBLIGATIONS, AND LIABILITIES.** All debts, obligations, and liabilities of the Company have been paid or discharged, or adequate provision has been made therefor under section 608.4421 of the Florida Limited Liability Company Act.

5. **DISTRIBUTION OF REMAINING PROPERTY.** All the remaining property and assets of the Company have been distributed among its members in accordance with their respective rights and interests.

6. **PENDING LAWSUITS.** There are no pending lawsuits against the Company in any court.
