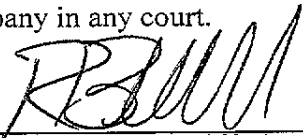

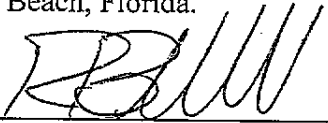

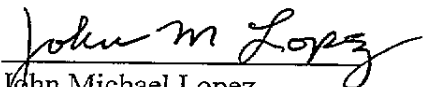
**MEMBERS UNANIMOUS WRITTEN AGREEMENT TO DISSOLUTION OF

A LIMITED LIABILITY COMPANY**

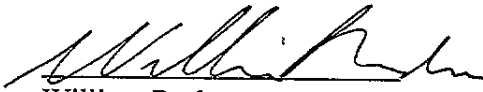
