#### ARTICLES OF ORGANIZATION OF PAT ROSE ASSOCIATES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I -- NAME

The name of the limited liability company shall be Pat Rose Associates, LLC ("company").

#### ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company is 3257 Fiddlers Hammock Drive, Ponte Vedra Beach, Florida 32082.

#### ARTICLE III -- DURATION
