

ARTICLES OF AMENDMENT OF THE ARTICLES OF ORGANIZATION OF LOTS, L.L.C.

The undersigned, the sole member of LOTS, L.L.C., a limited liability company organized and existing under the laws of the State of Florida (the "Company"), in order to amend the Articles of Organization of the Company in accordance with the requirements of Chapter 608, Florida Statutes, hereby certifies as follows:

- 1. The Articles of Organization of the Company were filed by the Department of State of the State of Florida on December 30, 1999.
- 2. The Amendment to the existing Articles of Organization being effected hereby is that resulting from completely deleting Article I of the Articles of Organization as of the date hereof, and by substituting in its place the Article set forth below.
- 3. As amended below, Article I of the Articles of Organization has the sole effect of changing the Company's name from "Lots, L.L.C." to "BTW Construction, L.L.C."
- 4. This Amendment to the Articles of Organization was approved by the sole member of the Company.
- 5. The Amended Articles of Organization shall be effective immediately upon filing by the Department of State of the State of Florida, all required taxes and fees having been paid, and thereafter the name of the Company shall be "BTW Construction, L.L.C." and Article I of the Articles of Organization of the Company shall read as follows:
