ARTICLES OF DISSOLUTION  
MORALES & HALL, P.L.

THE UNDERSIGNED, being the authorized Manager of Morales & Hall, P.L., a Florida professional limited liability company (the "Company"), hereby makes these Articles of Dissolution for the purpose of dissolving the Company pursuant to Section 605.0701(2), Florida Statutes.

ARTICLE I

The name of the Company being dissolved pursuant to these Articles of Dissolution (these "Articles") is Morales & Hall, P.L. The Articles of Organization of the Company were filed on December 30, 1999, and assigned document number L99000009403. The delayed effective date of the dissolution of the Company shall be December 31, 2021.

ARTICLE II

The effective date of the dissolution of the Company shall be December 31, 2021. Thereafter, the Company may continue solely for the purpose of winding up pursuant to (and to the extent permitted by) Section 605.0709, Florida Statutes.

ARTICLE III

The Company is being dissolved by the unanimous vote and consent of its Members owning all of the outstanding ownership interests in the Company, which is sufficient to authorize its dissolution under the terms of Sections 605.0701(2) and 605.0707, Florida Statutes. The person executing these Articles has been duly authorized to do so by the unanimous written consent of the Members of the Company.

ARTICLE IV

All of the debts, obligations and liabilities of the Company known to the Manager and the Members of the Company have been paid or discharged.


ARTICLE V
