is 1267 Port Lane, Sarasota, Florida 34242.

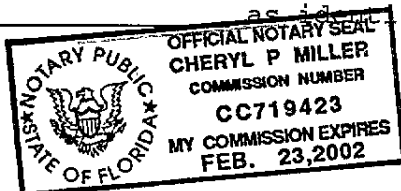

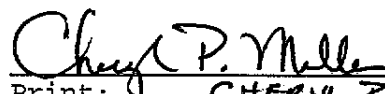
