- vehicles, automobiles, motor carriages, trucks, buses, tractors, multi-purpose vehicles, aviation equipments agricultural implements, boats, vessels, or otherwise howsoever, and machines, carburetors, implements, utensils, apparatus, lubricants, cements, solutions and appliances of any and every class and description and all parts or accessories used in connection therewith or pertaining thereto; and
- (c) Any and all goods, materials, wares and merchandise and devices, machinery equipment, tools, hardware, implements, parts, supplies, materials, accessories and appliances of every kind and nature which in any way or manner appertain thereto or which can be used in connection therewith; and generally to conduct a sales and service business with reference to all of the foregoing in all its branches.
- 2. - 4.
