You received from CT Corporation System an Application By Foreign Limited Liability Company For Authorization To Transact Business In Florida on behalf of CSX Lines, LLC. You have responded to the application by letter dated February 23, 2000

First, I want to explain that we did not respond to your letter until now due to an internal company situation, which might have rendered the application null and void. Second, as the person signing the application on behalf of CSX Lines, LLC, I want to apologize for a material error in the application. Specifically, the application shows, at line 6, date first transacted business in Florida as December 10, 1999. In fact, the company's business, which includes transportation of general cargo in container ships between Jacksonville, Florida and San Juan, Puerto Rico (and associated activities), has, and continues to be conducted by Sea-Land Service, Inc., the parent company of CSX Lines, LLC, and a Delaware corporation already authorized to do business in Florida.

CSX Lines, LLC's activities in Florida would only commence sometime after notice of receipt of authorization of that company to do business in Florida. Again, I apologize for the error and respectfully solicit your advice as to how to rectify this situation so that CSX Lines, LLC's application can be processed and approved or if a new application should be submitted.

Thank you for your anticipated cooperation and advice.

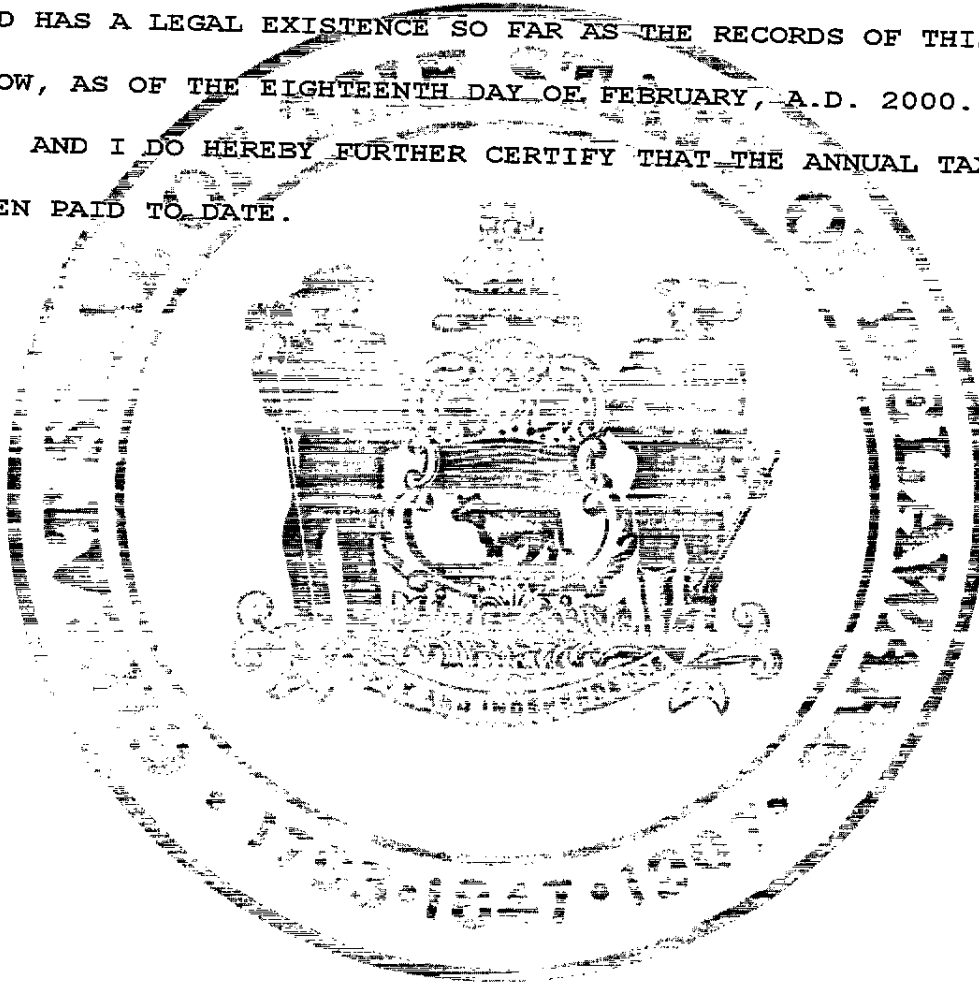
