

Pursuant to section 607.1502(4), 617.1502(4) or 608.502(4), Florida Statutes, this office collects a civil penalty of \$1000 for each year this entity transacted business or conducted its affairs in Florida prior to qualification and the appropriate annual report/uniform business report fees that would have been due this office had the entity qualified the year it began operations in this state. BEFORE ME, the undersigned authority, personally appeared SANDRA RAMIREZ-ARAIZ who is (known to me personally)(produced a valid drivers license as identification) and who deposes and says:

1. I am a Member of Further Lane Acquisitions, LLC, a New York Limited Liability Company which has filed an application for authority to transact business in Florida.

2. The application submitted contains erroneous information in that it does not clearly specify that the business of Further Lane Acquisitions, LLC does not constitute "transacting business" under F.S. 608.501(1) for the following reasons:

- The "business" of Further Lane Acquisitions, LLC is merely the one-time acquisition of a minority limited partnership interest in a broadcasting station engaged in interstate commerce (broadcasting stations are regulated exclusively by the Federal Communications Commission because they are engaged in interstate commerce). As such, Further Lane Acquisitions LLC is not subject to 608.501(1) because it is exempt under 608.501(2)(g), 608.501(2)(i), 608.501(j), 608.501(2)(l) and 608.501(m).

3. The one-time acquisition of a minority interest in an entity engaged in interstate commerce (which included a partial assumption of debt) is clearly exempt from the requirements of F.S. 608.501(1) and thus Further Lane Acquisitions, LLC is NOT liable for any civil penalty under F.S. 608.502(4).



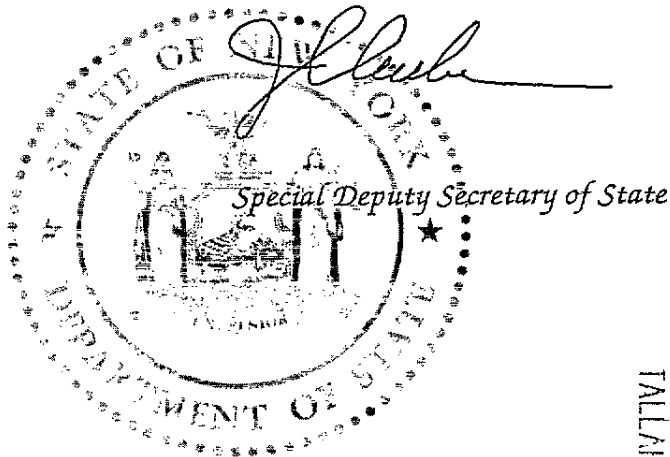
