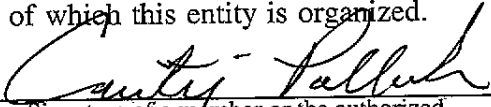

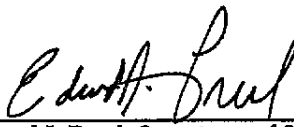

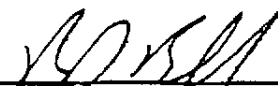
CERTIFICATE OF FORMATION
