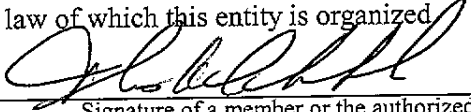

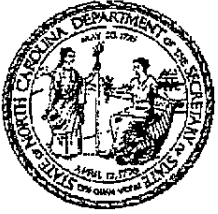
1. The name of the limited liability company is Medic Computer Systems, LLC.

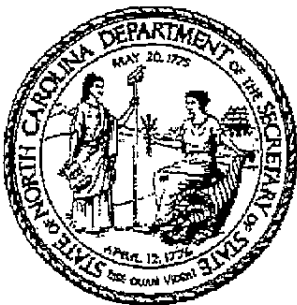
