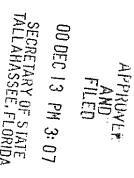

- 1.5 to hold financial assets that qualify for sale accounting treatment for purposes of Financial Accounting Standards Board Statement No. 125 ("FASB 125")
- 1.6 to sell the Class A Notes, Class B Notes, theclass C Notes, the Class D Notes, the Class E Notes and the VFN Notes pursuant to the Purchase Agreement;
- 1.7 to hold certificates representing a reversionary interest in the assets;
