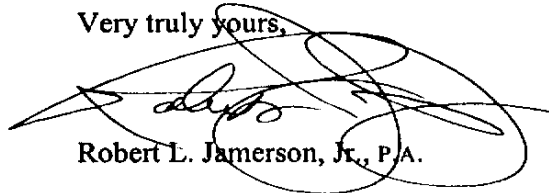
Re: **JDB HOLDINGS, INC. – Reinstatement**

Gentlemen:

Enclosed for filing is an Application for Reinstatement of the above-referenced corporation together a check made payable to the Department of State in the amount of \$300.00, representing the annual filing fees of \$150.00 each for 1998 and 1999. Pursuant to my telephone conversation with the Reinstatement Section of the Division of Corporations, the 1998 Annual Corporation Report Kit was never received by the above-referenced company from the Division because the Division inadvertently made an error when inputting the address for this company. Specifically, the Division failed to input the street address and the 1998 Annual Corporation Report Kit was never received and thus the 1998 Annual Report was never filed, thereby resulting in the administrative dissolution of the company. For your information, transmitted is a copy of the filed 1997 Annual Report as well as a 3/31/99 printout of the information for this corporation from the Division's internet site. As you will see, the street address was missing from the corporation's address on the internet site even though it was properly shown on the filed 1997 Annual Report.

In speaking by telephone with a representative from the Reinstatement Section, we were told that no penalty fees need be paid in connection with this reinstatement. The person I spoke with at the Division may have already attempted to correct the corporation's address within your computer system.
