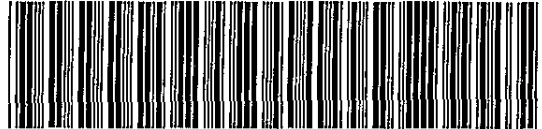

NAME

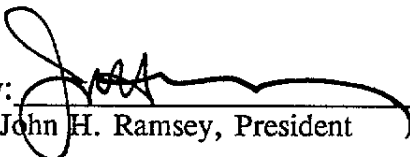
The name of the corporation (hereinafter called the "Corporation") is:

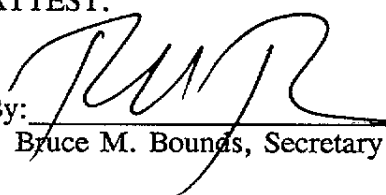
JOHN H. RAMSEY & COMPANY"
