Thank you for your help with regards to correct the registrations for Solantic, L.L.C.

As we discussed, in November 2001, I erroneously filed papers that created a Florida Limited Liability Corporation. My intention was to file papers which allowed Solantic, L.L.C. (a Delaware Limited Liability Corporation) to transact business in the state of Florida.

Solantic, L.L.C. was issued a Certificate of Formation from the state of Delaware June 6, 2001. I have included a copy for your review. In addition, I have contacted Delaware and requested an original certificate of existence. I will forward to your attention upon receipt.

Based upon our discussion, I should have registered Solantic, L.L.C. as a Foreign Limited Liability Corporation in Florida. I have completed this form and enclosed it along with a check in the amount of \$125. I have also enclosed this form along with a check in the amount of \$25.

The UBR which is due in May applies only to Florida Limited Liability Corporations and as such, I did not complete this document.
