PURPOSE CLAUSE FOR

PALMER & CAY OF VIRGINIA, LLC

The purposes for which this Limited Liability Company is organized are:

- (a) To engage in the business of acting as an agent and/or broker for insurance companies in soliciting, procuring, receiving and forwarding applications for property and casualty, life and accident and health, credit life, cargo and all kinds of insurance, together with the collection of premiums and the doing of such other business as may be designated to agents by insurance companies, including, but not limited to, consulting, including employee benefits consulting, risk management consulting, actual consulting and compensation consulting, and to conduct a general insurance agency and insurance brokerage business and to do any and all things incidental to the operation of any insurance agency, brokerage business and consulting firm which are permitted by applicable law.
- (b) To engage in any lawful act or activity for which a foreign Limited Liability

 Company may transact business under Florida law, including, but not limited to,

 manufacturing, purchasing or otherwise acquiring, owning, mortgaging, pledging,

 selling, assigning and transferring, or otherwise disposing of investing, trading,

 dealing in and with goods, wares and merchandise and property of every class and

 description, whether real, personal, mixed, tangible, or intangible; entering into or

 serving in any kind of management, investigative, advisory, promotional,

 protective, insurance, guarantyship, suretyship, fiduciary or representative

 relationship or capacity for any persons or entities whatsoever; and

(c) To engage in, conduct and operate any other business which may be deemed adapted, directly or indirectly to add to the profits of its business or to increase the value of its property.

In furtherance and not in limitation of the power conferred by the laws of the State of Florida upon foreign Limited Liability Companies organized for the foregoing purposes, the foreign Limited Liability Company shall have the power to borrow money, to lend money, to guarantee obligations, to purchase, construct, lease or otherwise acquire, own, hold, use, maintain, operate or otherwise manage or control, sell, exchange, lease, mortgage, pledge or otherwise dispose of, property of any kind or character, real, personal or mixed, tangible or intangible, necessary, useful or convenient therefor, and to acquire, hold, mortgage, pledge, or dispose of shares, bonds, and other evidence of indebtedness and securities of the United States of America or any state or municipality therein or of any domestic or foreign Limited Liability Company.

The foregoing clauses shall be construed as enumerating specific purposes and powers, but no recitation, expression or declaration of specific purposes or powers herein enumerated shall be deemed to be exclusive, but it is hereby expressly declared that all other lawful purposes and powers not inconsistent therewith are hereby included.
