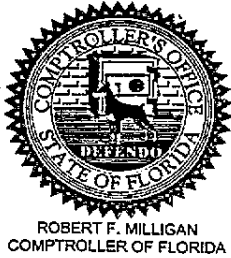

Reference is made to your recent request for approval of the use of the above-subject corporate name.




