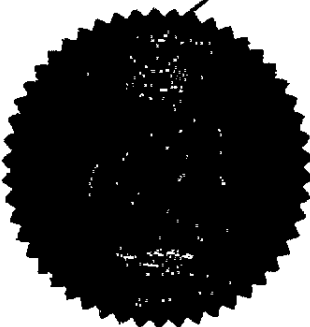


# STATE OF ALABAMA
