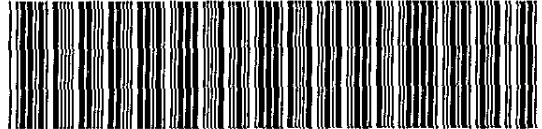


Regarding the \$1,050 late penalty, can you please reconsider this amount due to my ignorance to the filing procedures? I just simply did not understand that if my LLC was formed in Nebraska, that I was required to file under Florida also.

To further prove this, I do also have a Florida corporation formed in Key West, FL called "Key West Paradise, inc." in which I have always been timely with the corporate filing fees, local city & county occupational licenses, monthly sales tax collections, etc. I just didn't understand that I had to do this with the Nebraska LLC. I always try to do my best to lawfully turn in my forms when required.

Also, I just did not do a lot of business with the TamCam Vacation Properties, LLC in Florida. This LLC business is a single home vacation rental that I have in the Bahamas that I rented sporadically here and there to keep up with operating expenses, and bookings have been real slow since the September 11, 2001 incident. I work my Key West Paradise Florida corporation year-round, seven days a week.

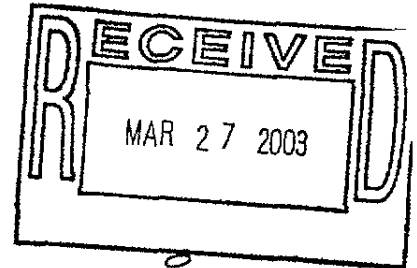

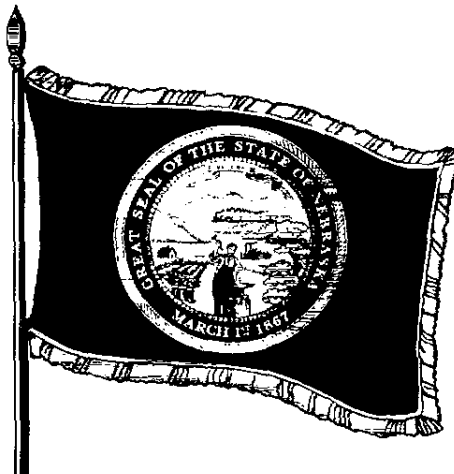

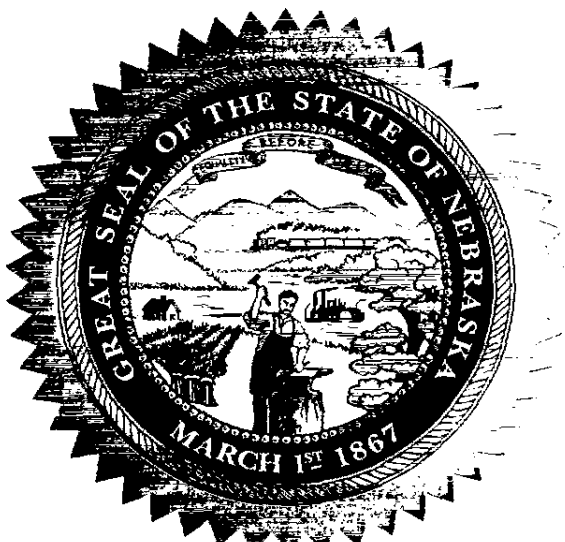
