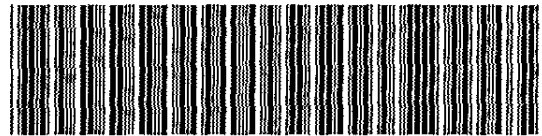


Please be advised I represent Karam Duggal, the Managing Member of the ~~above~~ Limited Liability Company.


