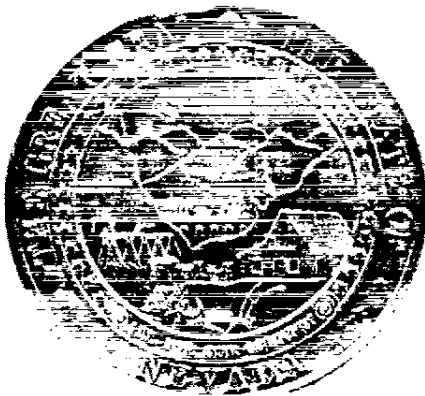


LIMITED-LIABILITY COMPANY CHARTER
