

Pursuant to section 607.1502(4), 617.1502(4) or 608.502(4), Florida Statutes, this office collects a civil penalty of \$1000 for each year this entity transacted business or conducted its affairs in Florida prior to qualification and the appropriate annual report/uniform business report fees that would have been due this office had the entity qualified the year it began operations in this state. The amount due this office to cover both annual report/uniform business report and penalty fees is \$1150.00.

Dear Mr. Bryan:

I have received your correspondence (copy enclosed) indicating that the documents we submitted to you in order to transact business in Florida were deficient. Outlined below are the documents I am now enclosing which will hopefully clear up these deficiencies.

First, I am enclosing a check in the amount of \$70, check number 077193, which covers the filing fee in regard to the Application by Foreign Corporation for Authorization to Transact Business in Florida. Second, the FEI number was inadvertently left off of the application and has now been included on the forms enclosed. Lastly, I have enclosed the proper Certificate of Existence from the State of Michigan for W.W.C., LLC.

The remaining issue involves the penalty fees in the amount of \$1150. You indicate that this amount is a combination of fees which the state of Florida collects as (1) a civil penalty of \$1000 for each year that W.W.C., LLC transacted business or conducted affairs in Florida, and (2) annual report/uniform business report fees. As noted on the enclosed Certificate of Existence from the state of Michigan, W.W.C., LLC has only been in business in Michigan since October 10, 2003, and it first transacted business in Florida on November 10, 2003. While we do not contest payment of the \$150 annual report/uniform business report fee and have enclosed check number 077194 in payment of that fee, we ask that you reconsider the \$1000 penalty covering a full year.


