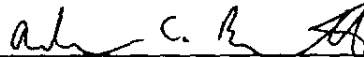

The Articles of Organization were filed with the Secretary of State of Georgia on AUGUST 25, 2004.

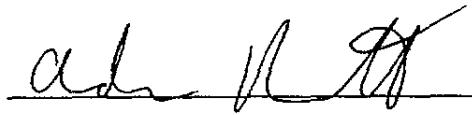
