

We are a small, independent newborn baby photography company. We have been taking baby pictures of newborns in some Florida hospitals since June of 2000. We received a Certificate of Registration from the Florida Department of Revenue, effective 4/24/00, and have always remitted the sales tax promptly. Unfortunately, we were not aware of the requirement to file with the Florida Department of State until January of 2003. When we became aware, we sent an application and checks totaling \$125.00 to the state of Florida.

When we received Letter 304A00042210, we attempted to locate the first letter that it refers to but have been unable to do so. The one we did receive was forwarded from our old location. We moved to our current location in August 2003, and suspect that the first letter did not get delivered to us.
