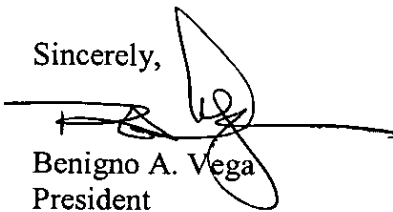
First of all excuse us for not having filed the annual report for the last two years.
