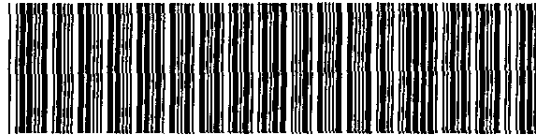

I have received the attached June 22, 2005 notice regarding the RT TEMPS LLC attempted filings and your return of the filed documents. I am responding to you to clarify the facts and circumstances about my company. My objective is to resolve your concerns and to comply with the Florida filing requirements.

My company, RTTEMPS (d/b/a RTTEMPS/RNTEMPS), is a Pennsylvania-based temporary staffing entity that has been in business for over 10 years. During that time, I have always sought to comply fully with all regulatory and filing requirements of all jurisdictions in which RTTEMPS conducts business. In fact, RTTEMPS was duly registered to do business in Florida through at least late-2004 as RTTEMPS, Inc. (d/b/a RTTEMPS/RNTEMPS). At that time, my independent accounting and legal advisors reorganized my business as RTTEMPS LLC (d/b/a RTTEMPS/RNTEMPS). In substance, nothing changed regarding my business operations, including clients, ownership, and personnel.

The problem seems to be form over substance. I had my staff seek to update all state filings to effectuate the name change. When Florida responded that a "name change" was not acceptable for Florida purposes, we followed your representatives' instructions by preparing and filing the new registration as an LLC, including the requested Certificate of Good Standing from the Commonwealth of Pennsylvania and the stated fee. We used December 1, 2004, instead of "upon filing" as the date the company first transacted business in Florida to correlate to our name change. In substance, my company has been and remains RTTEMPS/RNTEMPS as was filed with Florida before and after the December 1, 2004 reorganization.

Based on the foregoing, I respectfully request that you abate the \$1,050 asserted penalty fees and accept my application for authorization for RT TEMPS LLC to transact business in Florida as re-submitted with this letter. I have requested Corporation Service Company to serve as the registered agent. The Certificate of Designation of Registered Agent is attached. Thank you.
