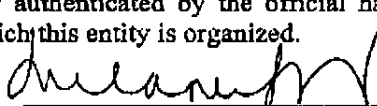

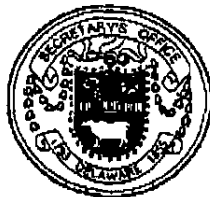

THIS AMENDED AND RESTATED CERTIFICATE OF FORMATION of CVS 4099 FL, L.L.C.
