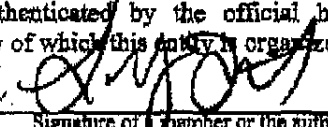

This Amended and Restated Certificate of Formation of Inland American Largo Paradise, L.L.C. ("I.L.C."), dated as of October 18, 2005, is being duly executed and filed by Scott W.
