AMENDED AND RESTATED SRV 054 CERTIFICATE OF FORMATION OF INLAND AMERICAN LARGO PARADISE, L.L.C.

This American Largo Paradise, L.L.C. ("L.L.C."), dated as of October 13, 2003, is being duly executed and filed by Scott W. Wilton, as an authorized person, in accordance with the provisions of 6 <u>Del. C.</u> §18-208, to amend and restate the original Certificate of Formation of Inland American Largo Paradise, L.L.C. which was filed on September 28, 2005 with the Secretary of State of Delaware (as heretofore amended, the "Certificate"), to form a limited liability company under the Delaware Limited Liability Company Act (6 <u>Del. C.</u> §18-101, <u>et seq.</u>).

The Certificate is hereby amended and restated in its entirety to read as follows:

FIRST. The name of the limited liability company is now MB Largo Paradise, L.L.C. (the "L.L.C.").
