Enclosed are completed applications to register two foreign corporations as authorized to conduct business in Florida.

As indicated on each application, the names of the entities are SFM Investment Partners, LLC and Mid-Atlantic Healthcare Partners, LLC, and they are based in Delaware and Maryland, respectively. In mid-2004, each entity agreed to invest in a Florida entity called Service First Mortgage, LLC ("Service First"), and each investment entity engaged in limited financial activity related to the funding of their investments. Each entity has since remained a passive investor in Service First, in that neither has taken any active or direct role in managing Service First or its operations, and neither has engaged in other business activity in Florida.

In August 2005, the investment entities filed an action in Florida state court against Service First's outside accountants. The accountants moved to dismiss the Complaint, citing section 607.1502, Florida Statutes. In their motion, the accountants did not identify any specific activity that they alleged constitutes "transacting business" within the meaning of section 607.1502. While the investment entities do not accept that their limited investment activities qualify as "transacting business" for purposes of section 607.1502, see Fla. Stat. § 607.1501(2); Crockin v. Boston Store of Ft. Myers, 137 Fla. 853, 859 (1939), they seek to avoid the delay and expense associated with contesting the motion, particularly as it concerns an issue peripheral to their lawsuit.

Accordingly, the investment entities are submitting the enclosed applications to register as authorized to conduct business in Florida. Please do not hesitate to contact me, or our Maryland co-counsel who also have knowledge about these matters, William J. Murphy or Daniel P. Moylan, should you have any questions.
