THIS AMENDED AND RESTATED CERTIFICATE OF FORMATION of CVS 5172 FL, L.L.C. (the "Company"), dated as of October 23, 2007, has been duly executed and is being filed by the undersigned, as an authorized person, in accordance with the provisions of 6 Del.
