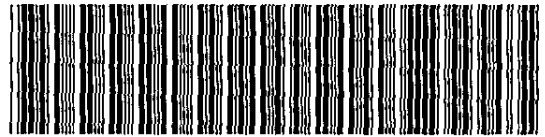

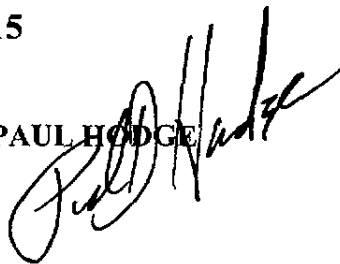

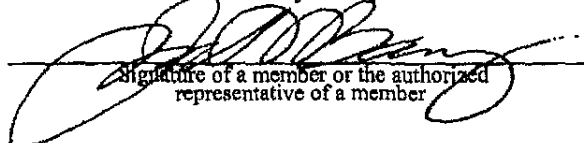

TO

SRA OPERATING COMPANY, LLC**

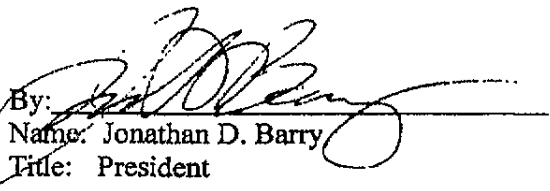
