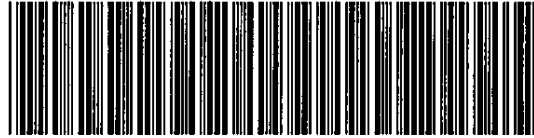



Pursuant to Section 490A.1101 of the Iowa Limited Liability Company Act, Chapter 490A, Code of Iowa ("Act"), R.W. Metals, LLC, an Iowa limited liability company ("Company") hereby adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the Company prior to these Articles of Amendment is "R.W. Metals, LLC".
