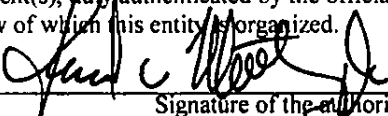

**ARTICLES OF AMENDMENT
TO THE ARTICLES OF ORGANIZATION OF
SPIRE, LLC**

TO THE SECRETARY OF STATE OF THE STATE OF IOWA:

Pursuant to Section 489.202 of the Iowa Revised Limited Liability Company Act, Chapter 489, Code of Iowa ("Act"), Spire, LLC, an Iowa limited liability company ("Company") hereby adopts the following Articles of Amendment to its Articles of Organization:

1. The names of the Company prior to these Articles of Amendment were: (i) "R.W. Metals, LLC" for the period October 1, 2001 through October 31, 2006, (ii) "Construction Products Distributors, LLC" for the period November 1, 2006 through January 19, 2016, and (iii) Spire, LLC for the period of January 19, 2016 through the effective date of this Amendment.

2. The date of filing of its original Articles of Organization was October 1, 2001.

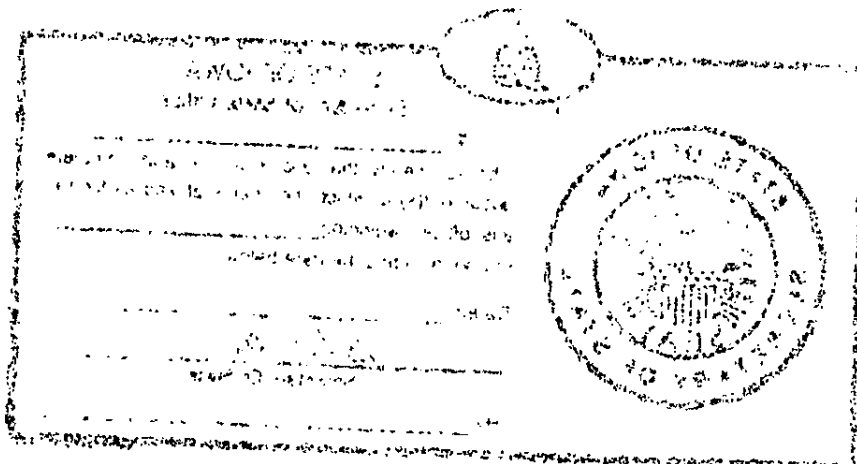
3. Article I of the Articles of Organization is hereby deleted in its entirety and the following is inserted in lieu thereof:
