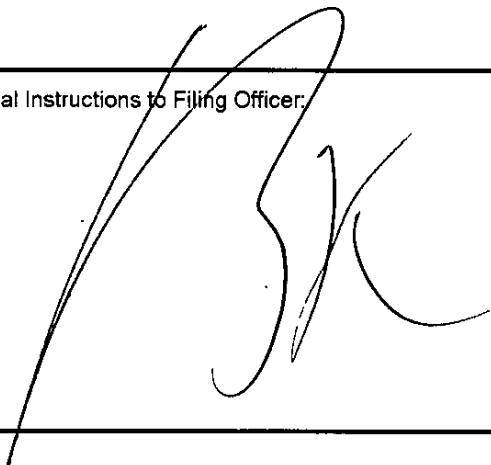

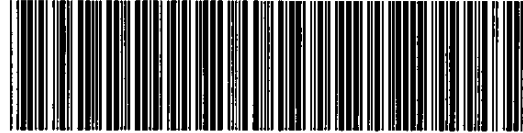

Hanesbrands Direct, LLC, a Colorado limited liability company which was formerly known as Sara Lee Direct, LLC ("Hanesbrands Direct"), has operated in Florida since it commenced operations in 2003. Prior to the spin off on September 5, 2006 of Hanesbrands Inc. ("Hanesbrands") from Sara Lee Corporation, a Maryland corporation qualified to do business in Florida (Employer Identification Number 36-2089049; "Sara Lee"), Hanesbrands Direct was a subsidiary of Sara Lee and was qualified in Florida by virtue of its status as an operating division of Sara Lee. In connection with the spin off, Hanesbrands Direct became a wholly owned subsidiary of Hanesbrands and obtained a separate Employer Identification Number (20-5720114) and is making this separate application for authority to do business in Florida.
