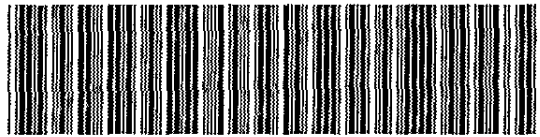


Ms. Lunt:
