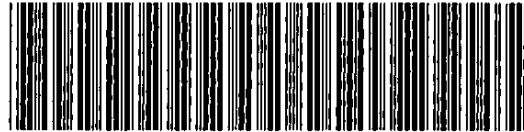


Per our telephone conversation on November 14, 2007, I am writing this request for waiver of the \$3,150.00 penalty for LeShea Enterprises, LLC.
