ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF STEPHEN J. CLIFFORD, M.D., P.A.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following amendments to its Articles of Incorporation:

Article I - Name

> The Corporation is organized for the purpose of engaging in the practice of medicine as allowed under the laws of the state of Florida and for the general purpose of transacting all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes. Despite the professional nature of the Corporation's first purpose set forth above, the Corporation is not a professional corporation and Florida Statutes Chapter 621 shall not apply in any manner to the governance of the Corporation.

Article III - Effective Date of Amendment

The effective date of the amendment to the Articles of Incorporation of the Corporation set forth herein will be as of December 15 2005.
