Ouestion 6 -- Date First Transacted Business in Florida

Proteus On-Demand Facilities, LLC (the "Georgia LLC") was formed as a Georgia limited liability company on September 18, 2003.

Subsequent to Georgia LLC's formation, the sole member of Georgia LLC intended to qualify the Georgia LLC to transact business in the State of Florida as a foreign limited liability company. However, instead of filing an Application by Foreign Limited Liability Company for Authorization to Transact Business in Florida, as was intended, the sole member of the Georgia LLC mistakenly filed Articles of Organization and the Florida Secretary of State formed Proteus On Demand Facilities LLC as a Florida domestic limited liability company (the "Florida LLC") effective October 4, 2006, which has Georgia LLC as its sole member.
